

DOUGLAS E. BEAUDOIN



Doug was born at Cincinnati, Ohio. An Eagle Scout, he served his troop as Senior Patrol Leader, Junior Assistant Scoutmaster and Assistant Scoutmaster and was a member of the Dan Beard Council Executive Board for two years (1983-1985).

He served as Chapter Chief (1981), Lodge Treasurer (2 terms, 1982-1983) and Lodge Chief (2 terms, 1983-1985) in Ku-Ni-Eh #145. He was on the OA Jamboree Service Corps in 1985.

Doug served as EC6A Section Chief for two terms (1985-1987). He was 1986 National Conference Vice Chief-Special Events and served on the NOAC Activities Committee in 1988.

His recognitions include the Vigil Honor, Founder's Award (1984) and the OA Distinguished Service Award received at the 1988 National Conference in Colorado.

Doug earned a B. S. in Business Administration at the University of Cincinnati, College of Business in 1991. Currently, he is employed as a Director of Management Information Systems in Cincinnati. He is a CNE (Certified Network Engineer), MCSE (Microsoft Certified System Engineer), and MCT (Microsoft Certified Trainer).

Richard H. Breithaupt, Jr.



Rick was born at Philadelphia, Pennsylvania. He earned a B. S. in Business Administration from California State University, Northridge and an MBA (with a minor in Computer Science) from California State University, Los Angeles. An Eagle Scout with three palms, he served in all youth positions of his troop. He served as Chapter Treasurer and Chapter Secretary; and two terms as Lodge Chief, being the last Chief of Walika #228 and the first Chief of Malibu #566. He served as Deputy Area Chief of XII-E and Section Chief of W4A. Rick served as a Chapter Adviser and was twice Lodge Adviser of Malibu #566.

As a recognized authority on Scouting insignia, during 1975-1976 Rick acted as a consultant to the National Council cataloguing its insignia collection housed at the Johnston Historical Museum (predecessor of the National Scouting Museum) located at the National Council's North Brunswick, New Jersey headquarters. This enabled the Museum to qualify for a Ford Foundation Grant. During his stays at the Augustus Scout House, the guest quarters at the National Office campus, he also completed his research of the Order of the Arrow's records and archives.

Rick and Albertus Hoogeveen published their first collaborative work, *Arapaho I: A History of Scouting Through Insignia*, in 1976. The joint effort of Rick, Albert and David C. Leubitz resulted in the original edition of *Arapaho II: A History of the Order of the Arrow Through Insignia*, published in 1979. Rick's research at the BSA's National Archives formed the basis of the lodge histories first published in Arapaho II, in each subsequent edition, and our software.

After serving as an Assistant Scoutmaster and Associate Post Advisor, Rick became a District Camping Chairman and District Chairman. Elected to the Council Executive Board, he served as Council Properties Committee Chairman and was later elevated to the Executive Committee. While serving as Vice President of Administration he was responsible for sale of the Council's two service centers and consolidation of its operation into new quarters. As Council Executive Vice President he was responsible for construction of the Council's new Scout Service Center. Rick served as Council President (Western Los Angeles County) in 1986-1987 and subsequently served on its Board of Governors.

Following two years as Section Adviser (W4A) in 1982 Rick was appointed to the Western Region Order of the Arrow Committee. In 1983 he was appointed Chairman of the Western Region Boy Scout Committee and a member of the Region's Executive Committee. He was elected Western Region Vice President of Personnel in 1986.

Rick was appointed to the National Order of the Arrow Committee in 1984. He served as Vice Chairman of the National Committee (1986-1991). He served as Lead Adviser, NOAC Special Events (1986) and Lead Adviser, NOAC Activities (1988, 1990). On staff at the 1985 OA Philmont Trek, he returned as Lead Adviser, Rendezvous (1989 OA Philmont Trek).



Rick was the principal author and editor of the revised *Order of the Arrow Handbook* (first published in 1989, reprinted in 1990 and later); the *Guide for Officers and Advisers* (1989); and the *National Order of the Arrow Bulletin*.

Nationally, he served on the Boy Scout Committee, Properties Committee, Personnel Group Committee, Personnel Development Committee, on the Board of Trustees of the National Scouting Museum (Murray, KY). As Vice Chairman of the Board of Trustees, National Scouting Museum, he chaired the National Museum's Capital Campaign.

Through fundraising activities for his Council and the National Council, Rick has raised about \$20 million for Scouting.

His recognitions include: and Silver Antelope Award; OA Distinguished Service Award; Silver Beaver Award; Vigil Honor; Founder's Award; District Award of Merit; and two Silver Thunderbirds (W4A). For distinguished service Walika #228 presented him its Silver Arrow Award and Malibu #566 presented its Silver Shark Award.

Rick is a real estate entrepreneur and writer.

Albertus Hoogeveen



Albertus was born at Lansing, Illinois and graduated with a B. S. in Electrical Engineering from Illinois Institute of Technology. His professional background includes employment in the aerospace industry on the Apollo program, at Cal Tech's Deep Space Network, Air Force Satellite programs and for the Military Network, predecessor of the Internet.

He has collected one thing or another for most of his life, beginning with stamp collecting. He has collected coins for over 50 years and served as President of the Numismatic Association of Southern California and several local coin clubs. He was honored with the Goodman Award for continued dedicated service to the hobby through the Numismatic Association of Southern California.

Albertus has been active in Scouting since 1964 and is currently registered as an Assistant Scoutmaster. He also serves as a District Camping Chairman. His past service includes being an Explorer Post Advisor. He earned the Explorer Advisor's Key and received his Woodbadge beads in 1973. Albertus served on council summer camp staff as business manager at Camp Whitsett (Western Los Angeles County Council) and as Camp Director at Lost Valley Scout Reservation (Orange County Council). He has also served as a volunteer commissioner on summer camp staff for ten years.

He has assisted local councils in raising in excess of \$300,000 through his knowledge of Boy Scout memorabilia.

Albertus has been active in the Order of the Arrow since 1968. He has served as a Chapter Adviser, Lodge Adviser (Wiatava Lodge #13), and Section Adviser of two sections: W4A (1984-1985) and W4B (1979-1982). He served on several NOAC staffs, including: Training, 1981, 1983; Special Events, 1986; Activities, 1988 and 1990; and Public Relations in 1996 and 1998. He also served on the 1989 OA Philmont Trek Rendezvous Staff.

Albert started collecting Scouting memorabilia in 1969 while attending his first National Jamboree. He has served as Assistant Scoutmaster or on staff for seven National Jamborees. He has also served as Assistant Scoutmaster, Scoutmaster and on Staff for five World Jamborees.

A long-time member of the Dutch Americans Singing Club of Southern California, Albert was a member of the XXIII Olympiad Opening Show in Los Angeles.

His recognitions include the Vigil Honor, Founders Award, District Award of Merit and the Silver Beaver Award. For his Distinguished Service to W4A he was presented its Silver Thunderbird Award, and Section W4A presented him its Silver Bear Award. Wiatava #13 presented him its Silver Arrow Award for Distinguished Service.
